## MANC BANKED SLALOM COMPETITION ENTRY

### TERMS & CONDITIONS

#### COMPETITION

##### Lift passes

A full slope pass will be issued for the duration of the competition, 0800-1600hrs.

##### Piste

The course will be protected from the public by red safety netting. Inspection will be conducted from the main slope the other side of the red netting so not to interfere with entrees training. Training will commence from 0800hrs until 1130hrs thus inspection on the course.

##### Timings:

**0730-1030hrs** Registration Open

**0800-1130hrs** Training (Inspection must be completed from the main piste side only)

**1130-1230hrs** Course Maintenance

**1230-1600hrs** Timed Runs (three runs must be taken within this time. No runs or re-runs regardless of the reason will be allowed after 1600hrs.

**1700hrs** Prize Giving

##### Prizes

Prizes will be awarded to the first three individuals in each discipline and in each of the following categories,

Para, Open, Children under 16 and Minis under 12.

**Team prize:** will be awarded to based on the combined times of three nominated members during registration. Amendments will not allowed to be made once Registration closes. Teams are comprised of three (3) mixed gender riders of a single discipline be it ski or snowboard. Team substitutions can be made in the event of injury or illness at the discretion of the Event Organisers.

**Para Prize:** Para ski and snowboarders will be entered into the main competition and eligible to with their respective age group. The results will automatically be entered into the overall Para competition.

There are no classifications or restrictions on disability, it is open to all. However, the para competitor must be able to safely navigate through the course. For Visually Impaired competitors, the time will be taken off the Visually Impaired competitor. The Guide must start from the side and not strike the timing beam at the bottom of the course. A safe exit point on the final turn will be identified in this case.

## Rules

## ENTRY AND REGISTRATION

By registering and/or entering competitions on the Cross Snowsport UKs competition entry system you confirm you have read and agreed to abide by the following terms and conditions:-

- 1. Conditions of Entry:** By completing the designated entry process participants are agreeing to abide by the following terms and conditions.
- 2. Completion of Entry Process:** It is the Participant's responsibility to provide accurate and truthful information when completing the entry process, any errors in data entered is the responsibility of the participant. If at any point the organiser discovers that the Participant has provided false or inaccurate personal information, or that the information provided makes the participant ineligible to participate in the Event, the organiser reserves the right to refuse entry or disqualify the Participant, without any refund of the entry fee and booking fee.
- 3. Payment:** Each Participant is required to pay the entry fee in full, along with any booking fees which may apply at the time of entry. Until full payment is received the entry is not guaranteed. Once payment is received and entry is confirmed, the fee is non-refundable other than otherwise stated within section 5 of these terms & conditions. Any booking fees are non-refundable in all circumstances.
- 4. Confirmation of Entry:** Entry to the event is confirmed upon completion of the entry process and payment of the entry fee. Entry will be confirmed via email to the email address provided by the Participant.
- 5. Competitor Withdrawal Policy & Refunds:** If the Participant wishes to withdraw from the competition at any point they must do so by informing the Organiser by email immediately to the race secretary for the competition they have entered. A Participant may withdraw free-of-charge and be refunded in full (minus booking fee) due to a medical reason (proof required). Any other refunds are at the discretion of the organising committee.
- 6. Transfer & Swapping of Entries:** Under no circumstances are participants allowed to transfer or swap their entry to another person or event. Entries cannot be deferred. Participants are requested to follow the guidelines as described in the withdrawal policy. Swapping of entries is strictly forbidden as it invalidates the event insurance, and places the individual's health & safety at the event at risk. There is no scenario whereby the organiser will grant permission to a participant to

swap their entry. Any participants and other involved individuals who are found to have swapped their entries will be banned from participating in all future events promoted by the organiser, and referred to the relevant Home Nation Association who may choose to implement further disciplinary action. Entries cannot be deferred to the next staging of the Event or to another event delivered by the event organiser.

**7. Competition Information:** All competition information required to participate in the event is published on [www.cross-snowsports.org](http://www.cross-snowsports.org) website. It is the participant's responsibility to read, understand and abide by the competition information. The event organiser reserves the right to change the competition information at any time without notice.

**8. Photography:** The organisers retain the right to use quotes, images, photographs and video taken by their contracted photographers and employees at the event without informing the participant if over 18 and including those under 18 years of age if approval has been given. These images will only be used for the purposes of promoting, reporting and broadcasting the event, and any other promotion related to the business activities of the Organiser.

**9. Competition Rules:** The competitions are run in accordance the World Para Snowboard Banked Slalom rules with any amendments can be viewed at [www.cross-snowsports.org](http://www.cross-snowsports.org).

**10. Event Changes:** The organiser reserves the right to amend the event at its sole discretion due to circumstances beyond its control, by way of changing distances or disciplines. This also includes the right to alter start times in these circumstances.

**11. Event Cancellation:** If the event is cancelled for reasons beyond the organisers control, including without limitation fire, storm, act of terrorism, "act of god", serious medical incident, no snow, then the participant will not be entitled to any refund or compensation of other losses by participants.

**12. Liability:** Participation in the Event is at the Participant's own risk. The Participant irrevocably agrees to hold harmless, indemnify and reimburse the Organiser from and for any sum, costs or expenses (including legal and professional fees) incurred, payable or paid by the Organiser to any person (including the Participant and/or any of the Participant's insurers) in connection with any accident, loss, damage or injury (including death) arising out of the Participant's attendance at and participation in the Event or any part thereof (except where any such injury or death is caused by the negligence of the Organiser or any of its employees or volunteers) and the Organiser's liability to the participant is excluded to the fullest extent permissible by law. Other than as stated below, the Organiser shall not be liable for any loss, damage or expense arising from an event of Force Majeure. The Organiser, its staff, agents or contractors shall not be liable for indirect or consequential loss or damage. The Organiser will not be liable for any computer result anomalies or any technical malfunctions. Whilst the Organiser takes every care with staging the event, the participant acknowledges that travel, personal accident and personal items insurance is his/her sole responsibility. The Organiser shall not be liable to the participant for any loss or damage of or to personal equipment belonging to the participant, or any indirect or consequential loss or damage whatsoever arising out of the participant taking part in the Event; or for any loss of business; revenue or profit; loss of reputation; anticipated savings or wasted expenditure; pledges made on your behalf or by you to charity. The Organiser will not be liable for any actions of any spectators or other third parties.

**13. Medical Conditions & Information:** All participants are required to provide emergency contact details as part of the entry process, and to disclose any known medical conditions to the Event

Organiser. The organiser reserves the right to refuse entry with no refund, if a participant fails to provide this information or the information provided is known to be false.

**14. Disability:** It is the competitor's responsibility to ensure they have the right level of physical ability to complete the event. If you know or are concerned that you have a medical condition which might interfere with your safe participation in the Event, before you enter you should seek advice from a relevant medical professional and follow that advice. Please see our Health Commitment Statement for more advice (below).

**15. Collection & Use of Data:** In accordance with EUGDPR the Participant agrees and consents to The Organiser using his/her personal details provided in his/her Online Registration Form and for the following purposes:

### **Event Administration**

(a) The Organiser requires a record of each participant's registration details including third party emergency contact details for internal administration purposes in order to properly conduct and to safely administer the Event.

(b) The Participant agrees to receive emails/SMS communication from the event organiser Cross Snowsport UK containing event information and updates before and after the event.

(c) The publication of the official start lists and results of the Event, and their inclusion in Cross Snowsport UK historical results database and as well as other reasonable statistical purposes. For the avoidance of doubt, the following Participant information shall be published within Event start lists and results: Name, Age, Age Category, Gender, Club and membership number as appropriate. In addition to this date, Date of Birth shall be passed to national seeder to enable matching of results to individual membership records, but will not be publically published.

(d) The participant accepts that the event's appointed photography partner, will be able to email them post event regarding the purchase of participant photos from the event.

(e) The participant accepts that Cross Snowsports UK may pass entry data to appropriate third parties for the purposes of data analysis and event administration on behalf of Cross Snowsports UK. No data will be sold to commercial third parties.

### **E-mail/SMS Communications**

(a) The Participant agrees that if he/she ticks the Cross Snowsport UK contact box at point of entry, their details will be used by Cross Snowsport UK to promote any other products and services including membership offered by Cross Snowsport UK in the future.

All participant data will be managed and stored in accordance with Cross Snowsport UK Privacy Policy.

**Doping:** I have read the Doping Control Regulations and agree to abide by them. I understand that testing for prohibited drugs may take place at competitions or squad training events and give permission for Doping Tests to be carried out.

**Health Commitment Statement Your health is your Responsibility.**

The Event Organisers are dedicated to helping you take every opportunity to enjoy your participation in our events. With this in mind, we have carefully considered what we can reasonably expect of each other.

Our commitment to you We will respect your personal decisions and allow you to make your own decisions about what exercise you can carry out. However, we ask you not to exercise beyond what you consider to be your own abilities.

We will make every reasonable effort to make sure our event are organised to accepted safe operational standards for you to enjoy. We will make all reasonable steps to ensure first aid is available at event in line with FIS requirements.

If you tell us you have a disability which puts you at a substantial disadvantage in accessing our event, we will consider what adjustments, if any, are reasonable for us to make.

Your commitment to us You should not exercise beyond your own abilities. If you know or are concerned that you have a medical condition which might interfere with your safe participation in our event, before you enter you should seek advice from a relevant medical professional and follow that advice.

It is the decision of the user, not the event organiser, to determine whether he or she is fit enough to exercise. If the user is in any doubt, the user should seek medical advice. It is up to the user where to seek that medical advice.

You should let us know immediately, if you feel unwell whilst participating in one of our events. Our staff are not qualified Doctors, but there will be first aid provision in attendance at our events.

If you have a disability, you must follow any reasonable instructions to allow you to complete our event safely. This Health Commitment Statement sets the standards that the Event Organiser and the event participant can reasonably expect from each other in regards to the health of the participant. This statement is for guidance only. It is not a legally binding agreement between you and us and does not create any obligation which you or we must meet.

**Doping:** I have read the Doping Control Regulations and I give my permission for Doping Tests to be carried out on my son/daughter/ward. I agree to abide by any regulations concerning Doping Control.

**Rules & Regulation:** I give my permission for my son/daughter/ward to agree to be bound by the Terms and conditions and all rules and regulations including disciplinary regulations of Snowsport England, BSS (British Ski and Snowboard and International Ski Federation as amended from time to time and agree to comply with the disciplinary and appeals procedures stated therein.

#### **Athletes Declaration**

In consideration of Snowsport England, Snowsport Scotland, Snowsport Wales, or Cross Snowsport UK registering me as a racer, I, the undersigned, understanding that my signature to this declaration does not limit the obligation of the organiser to prepare and maintain competition courses in accordance with FIS, British and Member Group rules and safety standards then in effect, make the following declaration.

**1. FIS, BRITISH AND MEMBER GROUP RULES, REGULATIONS AND PROCEDURES** I understand and accept that my participation at any event which is part of the FIS, British or Member Group calendar

is subject to my acceptance of all FIS, British and Member Group rules applicable in connection with such event. I therefore agree to be submitted to such rules, regulations and procedures and to the jurisdiction of the bodies which are in charge of applying them, including but not limited to the exclusive jurisdiction of the Court of Arbitration for Sport CAS in Lausanne, Switzerland, where such is provided by FIS, British or Member Group rules.

**2. ACKNOWLEDGEMENT OF RISKS** I am fully aware and conscious of the potential risks involved in competition ski & snowboard activities and of the risk caused by speed and gravitational forces, be it during training or during the actual competition. I recognise that there are risks linked with the attempt to achieve competitive results which requires me to stretch my physical abilities. I also know and accept that the risk factors include environmental conditions, technical equipment, and atmospheric influences as well as natural or manmade obstacles. I am further aware that certain movements or actions cannot always be anticipated or controlled and therefore cannot be avoided or prevented through safety measures. Consequently, I know and accept that when I engage in such competitive activities, my physical integrity and, in extreme cases, even my life may be at risk. Furthermore, I know and accept that the above mentioned dangers linked with my participation may threaten third parties within the competition and training area. I will conduct my own inspection of training and competition courses. I will immediately notify the jury of any safety concerns I may have. I understand that I am responsible for the choice of the appropriate equipment and of its condition, for the speed at which I race and for the selection of my line through the course.

**3. PERSONAL LIABILITY** I understand that I may be found personally liable to third parties for damages arising from bodily injury or property damage they may suffer as a result of an occurrence linked with my participation in training or competition. I agree that it is not the responsibility of the organiser to inspect or supervise my equipment.

**4. RELEASE** To the extent permitted by the applicable law, I release FIS, my National Association, Member Group, and the organisers and their respective members, directors, officers, employees, volunteers, contractors and agents from any liability for any loss, injury, or damage suffered in relation to my participation in FIS, British or Member Group sanctioned competition or training.

**5. DISPUTE RESOLUTION** Without limitation to the jurisdiction of any body of competent jurisdiction in connection with the application of the FIS, British or Member Group Rules, regulations and procedures to which I submit as a consequence of my participation at events that are published in the FIS, British or Member Group calendar (see point 1 above), I agree that any dispute which is not to be adjudicated in application of procedures provided for by the FIS, British or Member Group Rules, regulations and procedures, but which arises between myself and the FIS, British Ski and Snowboard, Member Group and/or the organizer of an event in the FIS, British or Member Group calendar, including but not limited to claims for damages of either party against the other arising out of occurrences (acts or omissions) linked with my participation to such an event shall be governed by the laws of England and Wales. This declaration shall be governed and construed according to the laws of England and Wales and to the extent permitted by applicable law shall also be binding on my heirs, successors, beneficiaries, next of kin or assigns who might pursue any legal action in connection with the same
